This map shows exotic forests greater than 50 hectares in extent. Forest ownership is shown for those owners/managers who were willing and able to provide spatial information on their forests. Ownership of some forest has not been identified.

Most boundaries and ownership details have been provided by either the forest owners or forest managers. Forest boundaries represent net stocked area, forest boundary or legal boundary. Forest boundaries were updated where information was provided as either digital data, printed maps, or scanned maps. Paper maps were scanned and forest boundaries digitised, using the existing boundaries in the Land Cover Database Version II (LCDB2).

The digital data are held by the Ministry of Primary Industries, for use in its activities, and are not publicly available.
