## PETANI.SG 13 March 2017 – Dogs and Cats to Singapore

### 1. Statutory authority

Pursuant to section 60, section 60A, section 62(1) and section 167 of the Animal Products Act 1999 I notify the following:

- (i) the issue under section 60 of the export requirements for Dogs and Cats to Singapore PETANI.SG dated 13 March 2017;
- (ii) the determination under section 62(1) of the format and content of the official assurance for Dogs and Cats to Singapore PETANI.SG dated 13 March 2017;
- (iii) the revocation and replacement of the export requirements for Dogs and Cats to Singapore DOMANIEC.SG dated 06 May 2013.

This notice takes effect from 13<sup>th</sup> March 2017.

### 2. Singapore requirements

Dogs and cats exported from New Zealand to Singapore must be accompanied by an official assurance in the form of a completed zoosanitary certificate.

The zoosanitary certificate as specified below must be completed and certified, after due enquiry, by an Official Veterinarian of the Ministry for Primary Industries.

#### **Explanatory note:**

If the zoosanitary certificate is not certified then the dogs and cats do not satisfy the conditions in the notice. Likewise, if the dogs and cats do not satisfy the zoosanitary requirements in the certificate, then the certificate will not be certified

All dogs/cats that are not presented in a cage with an intact seal or accompanied by an incomplete or falsely completed form may also be subject to quarantine by AVA.

**NOTES:** This certificate replaces that dated 6 May 2013. It has been updated to comply with the

World Trade Organization notification G/SPS/N/SGP/37/Add.2 to explicitly state the recommended age for the initial vaccination (i.e., six weeks of age and above). This certificate is a model certificate supplied by the Agri-Food & Veterinary Authority (AVA) of Singapore. The following notes have come from the Singapore import permit.

- 1. The dog/cat shall be accompanied by an original vaccination certificate, which also bears the identification code of the microchip that has been implanted. The vaccination certificate also bears the details (name of veterinarian, name and address of veterinary practice) and endorsement of licensed/registered veterinarian who vaccinated the dog/cat and verified the microchip identification code.
- 2. The owner or his agent must apply for the Import Licence by submitting an online application through AVA's website

  (http://www.ava.gov.sg/Services/AVAeServices/Permit Import Export Transship Animals Birds Eggs
  Biologics.htm) 30 days prior to the arrival of animals.
- 3. The owner or his agent shall contact the Quarantine Office as stated in the Import Licence at least five (5) working days before the arrival of the animals.
- 4. This certificate must not be dated more than 7 days prior to export.
- 5. The microchip that is implanted into the dog/cat must meet with ISO (International Standards Organisation) Standard 11784 or Annex A to ISO Standard 11785. If the dog is implanted with a microchip which does not comply with these ISO Standards, the owner of the dog or his authorised agent must provide a reader which is able to read the identification code for the implanted microchip at the point of entry into Singapore.
- 6. On arrival at the port of disembarkation in Singapore, the dog/cat and documents (Import Licence, Veterinary Health Certificate, Captain's Declaration and original vaccination certificate) shall be presented to and examined by an authorised Veterinary Officer. If the animal is found to be healthy and documents are in order, the animal shall be released to the owner or his agent.
- 7. If the animal does not meet the residency requirements upon arrival, the animal shall be quarantined at the Sembawang Animal Quarantine Station to make up for the shortfall in duration mandated by the residency requirement.
- 8. If any animal is not healthy or if any document is not in order, or quarantine space is unavailable, the animal shall be returned to the country of export, detained for up to two weeks for observation or destroyed at the discretion of the Director-General of Agri-Food and Veterinary Services.
- 9. Owners must ensure that the animal is transported in escape-proof containers conforming to the latest International Air transport Association's (IATA) Live Animal Regulations (if transport is by air).
- 10. Owners must ensure that the animal is not pregnant at the time of export.
